Education Benefits

TRANSITION CELL

The WWR Transition Cell continually seeks to improve its transition and employment support to Wounded, Ill, and Injured (WII) Marines and their families. The Transition Cell, manned by Marines and representatives from the Departments of Labor and Veterans Affairs, enhances community reintegration for WII Marines not returning to duty and helps them pursue careers in their communities.

EDUCATION BENEFITS

Benefit	Applies to	Description
Post 9-11 GI Bill	Active Duty	The Post-9/11 GI Bill offers benefits for attending education and training programs at accredited colleges or universities (or accredited non-college degree granting institutions). Post-9/11 benefit payments are tiered based on the amount of creditable active-duty service you have since Sept. 10, 2001. These benefits include: up to 100% tuition and fee coverage, a monthly living (housing) stipend, up to \$1,000 a year for books and supplies, a one time relocation allowance, and the option to transfer benefits to family members.
Reserve Educational Assistance Program (REAP)	Reserve	REAP is a program designed to provide educational assistance to members of the Reserve components called or ordered to active duty in response to a war or national emergency (contingency operation) as declared by the President or Congress. The Department of Defense and the Department of Homeland Security will determine who is eligible for this program.
Yellow Ribbon Program	Veterans	Veterans who qualify for the Post-9/11 GI Bill at the maximum benefit rate and military dependents who receive their education benefits through the new GI Bill's transferability provision are eligible for the Yellow Ribbon Program. This program helps with offsetting higher tuition costs for out-of-state students for tuition expenses at private colleges that exceed the standard VA reimbursement level for that state.

TRANSFERRING YOUR BENEFITS

Who can transfer their benefits?

Any member of the Armed Forces (active duty or selected reserve, officer or enlisted) who is eligible for the Post-9/11 GI Bill. For more information visit <https://www.dmdc.osd.mil/TEB/>.

Who can receive a benefit transfer?

An individual approved to transfer an entitlement to educational assistance under this section may transfer the individual's entitlement to: 1) The individual spouse, 2) One or more of the individual children, 3) any combination of spouse and child
